 - iv. Tori would like to propose reducing the HS Choir to \$12 dollars to offset the difference in the scoring. Everyone else would stay the same.

The recording must include complete cuts recorded continuously of both audition pieces recorded on the first take. The absence is only excusable due to KSHSAA State level events or National or National Qualifying Events for school sanctioned organizations.
