- II. HS Choir Chair report
 - a. Given by Tori Koehn (Leoti/Wichita County) HS Choir Chairperson
 - i. Dr. Terry Crull (FHSU) HS Choir Clinician
 - ii. Pam McGowne (FHSU) Accompanist
 - iii. Auditions went quite smooth!
 - 1. 386 Registrations/25 Schools entered/86 scratches/300 auditions
 - a. 116 Sops/85 altos/39 tenors/60 Basses auditioned
 - b. 206 in choir today!
 - iv. Lots of voice changes on the Audition Day creates a lot of problems
 - 1. At least 14 voice changes
 - 2. Very hard to change in the computer
 - 3. Should we add a fee for changes?
 - v. Liked having meeting upstairs in the Office
 - vi. We need to get more schools involved in the choir auditions and student participation.
 - 1. Shoot ideas of how to expand to these school to Tori Koehn
 - vii. How did we feel about the room split this year?
- III. From the State Presented by President Partin
 - a. KCDA President Melissa Grady
 - i. Sent survey to all KSHSAA choir directors
 - ii. Vast majority of responses (90%+) are in favor of changing the 456A large group requirements; prepare 3 pieces for large group contest instead of
 - 4. This change will most likely be in place by the 2023-24 school year.
 - b. Choir formula for All-State Choirs Troy Johnson
 - i. Moving octet and quartet (no change in Southwest)
 - ii. Auditions from all schools in our district is helpful. KMEA districts are in competition with each other for spots in all-state groups. School populations are used in the choir formula.
 - c. Congratulations to the Pratt High School Chamber Singers and Pratt Liberty Middle School Treble Choir for their selection to perform at the 2023 ISW!
 - d. Vote for board positions!

- e. Any new business?
 - i. Brandon Wade (Pratt) spoke about KSHSAA Music Committee
 - 1. Some directors don't like State Large Group
 - a. Many feel it is negative for small schools
 - b. Many looking at bringing clinicians to school instead of taking them to Contest
 - i. May want KSHSAA to provide monetary support to bring in clinicians
 - c. Overall, communities have many different and unique qualities, some are consistent, some have choir one year and not the next, then have it again. 6A groups beside 1A groups at festivals.
 - d. Would be nice if adjudicators have background on Western Kansas and smaller schools
 - ii. KMEA Past-President Gretchen Bixler (Goddard-Eisenhower) gave the example of what they do in the SC District. The Choir Directors during the HS Festival bring in one piece of music and have a choral reading session. This gives all Choir Directors the opportunity to hear music the district likes, not just what Music Merchants want them to hear.
