 - We will start the ISW on Thursday, Feb. 27 with the All-State rehearsals at 10:00.
 Opening session is at 10:30, followed by a reception. 44 performance groups selected and over 100 clinic sessions

 - Instrumental Live Auditions will be at Salina Central HS on January 11. Contingency is Jan. 18 at Salina South HS.
 - **This is a presidential election year. The candidates for KMEA President are Nancy Monical and Megan Gabehart
 - SW Division President-Elect elections will be open to eligible members on January 14, 2025, and will remain open through February 13, 2025. Please keep an eye on your inbox for the electronic ballot from YesElections (check your spam folder if you do not see it).

 Be aware that there are several KSHSAA events happening on the same weekend as ISW in 2025. The board is aware and has taken steps to help mitigate. Here is the exception wording voted on this past summer:

***Exception: The KMEA Board authorizes the release of varsity basketball players from the KMEA All-State and Honor Ensembles rehearsals to participate in their 1A Regional basketball tournament. This policy will be in effect for both boys and girls. Players' participation must be verified by their school's Administrator and they must be listed on the official KSHSAA roster form for the tournament. The school's Administrator will send a copy of the official KSHSAA tournament roster form to the All-State Ensemble Manager.

While no restriction on absence time has been indicated, the student MUST be at all KMEA rehearsals as much as absolutely possible. "KMEA recognizes the importance of the students to their community and school events but will not tolerate apparent abuse of this policy. The appearance of abuse may lead to reconsideration of this policy on the part of KMEA. KMEA WILL take precedence on Saturday and release for 1A regional basketball WILL NOT be considered." Prior to the first KMEA All-State and Honors Ensembles rehearsal, the All-State Ensemble Manager will provide the All-State Chairpersons a list of students to be excused.

***Exception: The KMEA Board authorizes the release of varsity basketball players from the KMEA All-State and Honor Ensembles rehearsals for the 2025 In-Service Workshop to participate in their 2A or 3A Sub-state Quarterfinal basketball game. This policy will be in effect for both boys and girls. Players' participation must be verified by their school's Administrator and they must be listed on the official KSHSAA roster form for the tournament. The school's Administrator will send a copy of the official KSHSAA tournament roster form to the All-State Ensemble Manager.

While no restriction on absence time has been indicated, the student MUST be at all KMEA rehearsals as much as absolutely possible. "KMEA recognizes the importance of the students to their community and school events but will not tolerate apparent abuse of this policy. The appearance of abuse may lead to reconsideration of this policy on the part of KMEA. KMEA WILL take precedence on Saturday and release for 2A and 3A Substate Quarterfinals basketball game WILL NOT be considered."

Prior to the first KMEA All-State and Honor Ensembles rehearsal, the All-State Ensemble Manager will provide the All-State Chairpersons a list of students to be excused.

***Exception: The KMEA Board authorizes the release of varsity bowlers from the KMEA All-State and Honor Ensembles rehearsals to participate in their Regional bowling tournament. This policy will be in effect for both boys and girls. Players' participation must be verified by their school's Administrator, and they must be listed on the official KSHSAA roster form for the tournament. The school's Administrator will send a copy of the official KSHSAA tournament roster form to the All-State Ensemble Manager.

While no restriction on absence time has been indicated, the student MUST be at all KMEA rehearsals as much as possible. "KMEA recognizes the importance of the students to their community and school events but will not tolerate apparent abuse of this policy. The appearance of abuse may lead to reconsideration of the policy of the part of KMEA. KMEA will take precedence on Saturday and release for Regional Bowling WILL NOT be considered."

Please note that the 2 and 3A basketball is an exception for this year only. We realize the impact that these KSHSAA competitions are going to have on our choirs, 1234A band and 12A honor band. We hope that you will continue to encourage your students to audition with these exceptions in place. Also, we would appreciate any feedback/data on the impact that this has with your students this year. Please share your information with your district president or the KMEA executive committee so that we can take this information to KSHSAA and hopefully enact change.

- REGIONAL AND STATE PIANO FESTIVALS New piano rubric will be used this year Piano Rubric
- **DUETS** (New manual language for festivals 2025)
 - 6. Duets must be published duet music.
 - a. 1A and 2A schools may perform band duets on two unlike wind instruments or two unlike percussion instruments, but not a combination of a wind instrument and a percussion instrument. Acceptable examples: flute/tuba; trumpet/alto saxophone; marimba/xylophone. Nonacceptable examples: flute/snare drum; tuba/timpani; piccolo/ vibraphone. All like instruments are allowed. i.e. Two trumpets, two flutes, etc.
 - b. 3A, 4A, 5A and 6A schools may perform band duets within their family of instruments: two woodwinds, two brass, or two percussion instruments. Acceptable examples: flute/clarinet; trumpet/trombone; marimba/xylophone. Nonacceptable examples: flute/trumpet; tuba/snare drum; piccolo/ vibraphone.
 - c. All schools may perform string duets in any combination of the following two instruments: violin, viola, cello, string bass, harp.
