 - i. Possible change for next year: The All-State percussion audition includes auditioning on mallets, snare, auxiliary and timpani. We need to decide as a district what our expectations will be for next year - keep our same

- individual instrument auditions we currently use or match the state audition procedure or some combination of the two?
- ii. Important notice for directors: We need to be extra clear, especially with new directors or new-to-auditioning directors, that there is to be no talking on the recordings. We had several instances of students introducing themselves and their school on the recordings, which automatically disqualified them.
 - 1. We will check policy to make sure it is clearly stated in the audition instructions.
 - Craig Lyman brought up that there are some discrepancies between the district audition and the state audition guidelines.
 Asked to make sure they are consistent. Tori asked him to send specifics to her so she can update the website.

 - c. Possible change for next year: The All-State percussion audition includes auditioning on mallets, snare, auxiliary and timpani. We need to decide as a district what our expectations will be for next year keep our same individual instrument auditions we currently use or match the state audition procedure or some combination of the two?
 - Grant Mathews from Great Bend said we should keep it the same to not detour any students. Jeffrey Poort from Pratt said if we did two instruments and meet in the middle with auditioning on two and primarily do snare and mallets.
 - ii. As a district keep it the same where they audition on one instrument for percussion. If they audition on multiple instruments, they must have a preference entered for District.

d. Auditions

- i. Clarifying policies that state you either audition for Band or Choir and not do both.
- ii. We need to add a required field for preferences if students audition on multiple entries.

e. Unison Etude

- i. Discussion brought up about if the unison etude for our district and if it is useful for the bands. Having a unison etude made it easier for small schools who don't have a large repertoire. Pratt band director mentioned that getting rid of the Etude would be ok because each instrument also has its own excerpt and seems extra for their district audition.
- ii. Suggested from majority to select two of the state excerpts (technical and lyrical or contrasting style) and scrap the unison etude. Mac will send out an email to collect data to be voted on at the Summer Board Meeting.
